## 2020 ELECTION TIME FRAME

- Spring and Summer 2020: Nomination of Electors.
- Sept. 14, 2020: Mail-in Ballots sent out for General Election in NJ
- Oct. 13, 2020: Last day too register to vote
- Nov. 3, 2020: Election Day
- Dec. 8, 2020: Deadline for Resolving Election Disputes
- Dec. 14, 2020: Meeting of the Electors
- Dec. 23, 2020: Deadline for Receipt of Ballots
- Jan. 6, 2021: Counting of the Electoral Ballots
- Jan. 20, 2021: Inauguration Day





# TYPICAL ELECTION CYCLE

- Spring of the year before an election :Candidates announce their intentions to run
- Summer of the year before an election through spring of the election year: Primary and caucus debates take place
- January to June of election year: States and parties hold primaries and caucuses
- July to early September: Parties hold nominating conventions to choose their candidates
- September and October: Candidates participate in presidential debates
- The first Tuesday after the first Monday in November: Election Day
- December: Electors cast their votes in the Electoral College
- Early January of the next calendar year: Congress counts the electoral votes
- January 20: Inauguration Day



According to Article II of the Constitution the President has the following powers:

- Veto bills and sign bills.
- Represent our nation in talks with foreign countries.
- Enforce the laws that Congress passes.
- Act as Commander-in-Chief during a war.
- Call out troops to protect our nation against an attack.
- Make suggestions about things that should be new laws.

- Lead his political party.
- Entertain foreign guests.
- Recognize foreign countries.
- Grant pardons.
- Nominate Cabinet members and Supreme Court Justices and other high officials.
- Talk directly to the people about problems.
- Represent the best interest of all the people





# THE ELECTION PROCESS

- Step 1: Primaries and Caucuses
- Step 3: The Electoral College

Step 2: National Conventions and General Election

## THE ELECTORAL COLLEGE

- There are currently 538 members of the Electoral College.
- Each state gets as many electors as its number of representatives in Congress.
- Each state has at least three electors, because each state has two Senators and at least one member of the House of Representatives.
- Representation in the House is determined by the U.S. Census, conducted every 10 years.
- Candidates must receive more than half of the total votes to win an election. Half of 538 is 269, so a candidate must receive 270 electoral votes to win. If no one gets that number, the House of Representatives decides.

# POPULAR VOTE

- Voters cast their ballots on the Tuesday after the first Monday in November.
- Although voters choose their preferred candidate the popular vote does not officially determine the president.



CONSTITUTIONAL AMENDMENT TO LEGALIZE MARIJUANA

CONSTITUTIONAL AMENDMENT TO CHANGE THE LEGISLATIVE REDISTRICTING SCHEDULE IF CENSUS DATA IS DELAYED

Do you approve amending the Constitution to change when new legislative

The current COVID-19 pandemic has delayed census data collection. If New Jersey does not receive the census data in a timely manner, new legislative districts may not be ready in time for State legislative elections in the year ending in one.

This change to the redistricting schedule will allow legislators to be elected that year from their existing districts for their two-year term in office. The new districts will be used starting with the next scheduled general election for the State
