Children's Advocacy Mission:

- This program connects children with IDD to the appropriate state services that will help them develop and achieve long term goals. The program works dir
- ectly with children and families, state agencies, and members of the New Jersey Legislature.
- To provide individual and systems advocacy related to Early Intervention (EI), the Children's System of Care (CSOC) and PerformCare, special education, and related services



Strategy

- Uphold our standard as the "go-to" place for children with IDD and their families
- Develop innovative content to make information more accessible to a wider audience
- Increase our presence in the community by attending family resource fairs
- Participate in inter-agency workgroups and advisory committees
- Provide direct advocacy and assistance to help families navigate the service systems in New Jersey
- Establish relationships with state agencies to improve IDD-related services



Who Does This Program Serve?

Children ages 0-21 and their families Connect them with various systems in New Jersey

- Early Intervention, Children's System of Care (CSOC), PerformCare, etc
- Assist families with accessing services through their local school districts
 - Provide Individualized Education Plan (IEP) / 504 Plan reviews
 - Attend IEP meetings and advocate on the student's behalf



Assistance for Families

- Explain the rights of their students to have a Free and Appropriate Public Education (FAPE)
- The parents/guardians rights as a member of their student's Child Study Team (CST)
- Connect with local or state level resources
- Assist with understanding the school, community, and state resources available to their children
- Validate the family's experience and alleviate the stress of feeling unheard or isolated
- Connect with family-oriented activities in the state to increase their community involvement



Family & Child Advocacy

- Child age 0-3 concerned about possible delays
- Child age 0-3 already enrolled in Early Intervention
- Pre-school child with a disability
- Pre-school child with a suspected disability
- Child beginning the process of getting an Individualized Education Plan (IEP)
- Child denied for IEP, working on establishing a 504 plan
- Child has a 504 plan, but the family believes they need an IEP
- Child/Adult in need of transitional services




Family & Child Advocacy

When I receive calls similar to those in the examples on the last slide I can:

- Put the family in touch with agencies for specific care (PerformCare, Early Intervention)
- Schedule meetings to brainstorm IEP/504 plan accommodations or needs
- Attend meetings with the school district
- Attend mediation and due process meetings


Statewide Systems Advocacy
