A program offered through the Department of Human Services (DHS) and the Division of Disability Services (DDS) that offers individuals with disabilities who are working and earning income that would typically disqualify them from receiving Medicaid/NJ FamilyCare, the chance to receive full health benefits. Eligible individuals pay a small premium and receive comprehensive Medicaid coverage.

As of April 1, 2023, Phase 1* of WorkAbility is:

- Open to all people over age 16 who have a disability determination
- Free from spousal deeming requirements
- Free from asset limits

Who qualifies?

- NJ residents and U.S. citizens
- People who meet specific noncitizen requirements
- At least 16 years old
- Employed full or part time and able to show proof of employment
- Determined to be disabled by the Social Security Administration (SSA) or the Medical Review Team at the Division of Medical Assistance & Health Services
- Within the income threshold

Note: SSA qualifies someone as having a disability if:

- You have a physical or mental impairment, or a combination of impairments, and
- Your condition has lasted or is expected will last for a minimum of 12 months

What is the income threshold?

The income threshold is determined through your unearned and total earned income

- Unearned income is determined through, but not limited to:
 - Alimony
- Social Security benefits based
- Unemployment
- on a parent or spouse's work
- Investments

Interest

- history (including Social Security Disability Insurance
- Trust payments
- (SSDI) and Survivor's benefits)
- A single individual cannot exceed \$1,215/month
- A married individual cannot exceed \$1,644/month
- Total earned income is determined through, but not limited to:
 - Wages
 - Paid sick leave
 - Workers' comp
- Self-employment earnings
- Private or state temporary disability plan benefits/ commissions

- If you have no unearned income:
 - A single individual's gross earned income cannot exceed \$73,932 per year/\$6,161 per month
 - A married individual's gross earned income cannot exceed \$99,636 per year/\$8,303 per month (spouse's income is not included)
- If you have unearned income:
 - The maximum earned income threshold will vary, but the total countable income, both earned and unearned income, cannot exceed the above limits
- Are there exceptions to these income limits?
 - There may be portions of earned and/or unearned income which are not counted in determining WorkAbility eligibility, however, this can vary by individual circumstance
